Meeting minutes

Meeting called to order at 7:06pm

1) Approval of July 2018 Minutes

Motion to approve by Emma; seconded by Josh; unanimously approved, carried

2) Approval of August 2018 Minutes

Motion to approve by Emma; seconded by Stephen; unanimously approved, carried

3) Approval of Agenda

Motion to approve by Emma; seconded by Josh; unanimously approved, carried

4) Finance Report & budget updateAdditional information: 2 months. Not a lot of activity in Aug or Sept. Except for memberships.

Motion to accept the Aug and Sept monthly financial reports as information by Dan; seconded by Steve; unanimously approved, carried

5) Items for discussion

- Guest of the president: EFCL energy transition officer Ronak Patel: no one in attendance to report.
- Guest: Telus fibreoptic representative: Scott Roberts (senior research marketer for the build) and Ayanna Rhindress (region market manager). Here to answer questions. They are engaging all CL that they build in. They will also be the ears of everyone for remediation. Their goal is the education on why, process, etc. In short, it all started in 2015 and will end up costing \$1.6 billion. Their goal is to establish fibre lines for entire city of Edmonton. They are doing so area by area. Most of the lines are buried. Start stop due to winter. They are willing/enthusiastic to have a table at community events to field questions. Carrie will send info on the events. They will provide us with a FAQ for our newsletter.

A question for them: What are the standards with which they will leave the lawns/damage to driveways, etc.? All will be back the way it was. Lance: The shifting core repairs are a concern.

What are the next steps? You can expect a construction notice 2-3 months before there are feet on the ground. There will then be

representatives going door-to-door requesting permission to bring the fibre to homes (although there is no obligation for purchasing). Next summer there will be a backfill of grass. Once the quadrant is done, the activity of the fibre optics will go live and the salesmen will head out to our area. It is expected to that an area is completed within 18 mos. Some unexpected surprises has delayed some builds.

- **Preschool report:** will present budget before the end of November
- **Soccer report:** No one in attendance to report. Dan reports that Perry has done his fall/indoor drive
- Hall rental report: lots of asks, but not many dates available.
- Energy efficiency project report: website daily energy usage/production, Dec 12. Will likely be a few thousand dollars short. The grant is a bit lower than expected. Kuby should have completed the work in May. However, the wiring was messed up. This resulted in \$4600 above for work hours. An option would be to contract it out. Lance suggested to Kuby that we split cost 50/50. Next meeting, will need a motion to accept the overages, but until we have the totals...
- **Rio Terrace playground report**: still in the fundraising phase. Proposal: they are currently unable to provide tax receipts for donations. Could we use the building society such that we can distribute tax receipts? Is this against the society act? What does this look like? Something to consider.

Old business

Motion to donate all proceeds from the big bin event 2018 to the Rio Terrace playground project by Rachelle. Seconded by Giselle. Unanimously approved, 1 abstention (Rachelle); carried

2. Upcoming events:

- German bazaar (Mulled wine thing) is on Nov 30th. Shay will ask the board to send a poster for the newsletter.
