3) Finance Report & budget update

Additional information: Provided for both April and May, May is the year-end. He is not getting into audit swing by looking at the results compared to the budget. In summary, there is a big difference related to casino funds not landing. Soccer was a bit low, but the budget was ambitious. Expenses were lower than expected, but so was our incoming. Casino account is close to 0 (which is a good thing). We have money. **There may be a little bit of grant money going back to the city. We were under budget.**

Replace rink ply wood good opportunity to replace it before it is used.

September 21<sup>st</sup>. Is James available to do membership drive? Emma to email James. Giselle, Gary, Stephen are available to volunteer.

- A. Preamble: We received a letter from the city to declare our use of tax dollars. This requires a motion in the minutes. Since we pay no tax, this doesn't matter but a motion needs to be made to declare a %. I would suggest a motion to declare 100% funding for EPSB since we don't have any Catholic schools in the neighborhood.

# Motion: I move that we direct 100% funding for the Non-Roman Catholic school district.

- NRC report Una (as per distributed June report): Pitch your project is the major thing that she would like to bring to our attention. Up to \$1000. Register as an individual or community. School or church or org (with a fiscal agent) has to be involved. No one has any ideas. Lance would like to put forth a geocashing idea. It is in Sept. Away July 15-19, July 31-Sept 2. Get your application in early. Register your parkland events early. You have to be present and make a 2 min presentation.
- President Lance: Wellness clinic has 2 new people. Will send out an email welcoming them. Wellness clinic is doing YOGA in the park. Oxford is taking the empty space in the strip mall.
- Vice President : no one in attendance to report.
- Membership James: no one in attendance to report.
- Programs & Social Stephen: talked about in old business "upcoming events".
- Signs Stephen/Jen: YOGA in the park free by donation (fundraiser for the park). Stephen will write something up. Bike parade sign is up. Jack is gone on 4<sup>th</sup> of July.

Electronic sign - The city is moving away from electronic signs because there have been complaints. If there is lots of visibility from residents, then it is not likely to pass. But ours faces the park. Ones on the building have more leeway. Lance to send Una the info and she will talk to the parks person. Talk to the people on the street. Bring a brochure to them. Shut off/dim at night.

• Maintenance – Gary: Stephen would like new basketball nets. Cost? Not expensive. He will buy and the league will reimburse. Gary bought a new volleyball net. Stephen and Lance will put it up. There are holes in the plywood behind the net and need to be replaced. Peter Kope (our rink attendant last year) could do the work. We need to consider sealing the bottom of the boards (liquid rubber).

Window of the preschool is fixed. Billed the RTCL.

Storage shed is being used as intended. Yay!

Grafitti on the walls again. Lance will paint them again.

Latch on gate is broken. The lock is gone.

The weeds need to be taken care of inside and outside the rink. We might need a commercial grade whipper snipper... We could rent one? Golf course – herbicide (Rachelle). Hire a company (\$2200?) – Dan has a client that is a cheap handy man. He'll ask.

Motion to allocate up to \$1500 to spend towards cleanup of the hall grounds (inside outside rink, tennis court, and parking lot to the front of the building) by Dan. Seconded by Giselle. All in favour. Carried.

Peter Kope will be the rink attendant again next year. Floors will be waxed after the summer party.

• Newsletter – Giselle:

Regarding content from political candidates: at the moment, we allow paid advertisements from political candidates/ parties and nothing else. Currently elected officials like Lorne Dach has written articles for us. The federal Conservative Party candidate's team is asking if they can write an article as well.
